- 2) Brief review of minutes from September 9, 2020 meeting. Minutes carry as read.

- 4) Committee Reports:
  - a) Safety Report: No report.
  - b) Maintenance Report: Bill reported that we had our second clean-up for the fall. Three people showed up. Don Delise had recommended a clean up service. Bill had them come up and give us an estimate to do the CPW required clean-ups. (Side note: Bill has been using leaf blowers to push the wads into piles, which works well). The service came up with an estimate of \$450 for each clean up. Two clean ups a year would cost \$900, which is cheaper than the \$1,200 we pay out for working rounds given to members for their time working on clean

up days. A motion was made to use this clean up crew for a test demo for \$450. Motion carried.

Bill asked Keith Goddard from CPW if he would spray our ranges for weeds when he sprays the rifle/pistol ranges. Keith agreed as long as RFVSA pays for the weed killer. This would be done in the spring.

Basalt Maintenance came up and installed a new rope in the in the flagpole at the range. This was thanks to Bill Kane.

MEC came out and serviced all our 5-stand machines. Cory Howell is coming out October 12th-15th to service trap and skeet machines.

It was recommended that the club change from using paint for the pattern board to using lithium grease. Easier maintenance and less supplies. The general feeling was keep using paint.

A recommendation was made to service the tractor. No action was taken.

A recommendation was made to build/purchase a 10' by 10' shed to be placed up on the skeet range. This recommendation was tabled.

c) Overhead Platform Report:

Ladder lift has been ordered. Target machine that RFSA is buying has been ordered and our new rabbit machine has been ordered.

5) Old Business:

- a) A discussion about a former RFVSA member returning to the club and shooting a couple of weeks ago. The member was banned several years ago for inappropriate behavior and there was discussion on how to proceed if he comes back. The discussion will be continued at the next meeting.

6) New Business:

- a) An absentia motion was made by Jim Perry to not allow resources
