- 1) Call meeting to order: 5:31 PM
- 2) Brief review of the minutes from February 3, 2021 meeting. Minutes carry as read.
- 3) Treasurer's report:
Checking: \$18,095.00

Savings: \$21,304.00
- 4) Committee Reports:
 - a) Safety Report: A reminder to the membership to be aware of putting away your shotgun and be sure to unload your firearm when finished shooting. Always treat all firearms as if they are loaded.
 - b) Maintenance:
 - 1)The target machine in the high house of the skeet field has been rebuilt and is working well. It was mentioned that the counter for the low house is sticking and giving the wrong target counts.
We need helpers to help move the target machine out of the trap house and into the CPW shed. That will happen on March 17th. Also, March 24th, we will need help to move the target machine out of the lower trap house to the upper trap house to make room for the new wobble machine coming in April. April 1st and 2nd Howell Traps will install the new wobble machine and rewire the machine that was moved to the upper house. Two helpers will be needed for that project. Those two days will be blacked out and there will be no shooting on those days.
The skeet warehouse ladder has arrived and we will be installing it next month to provide access for the platform and new target machine a top of the low skeet house. Also, the ladder lift for the lower trap field will be installed in April.
Target order will be arriving Saturday, March 20. Bill Bendl will be running point on coordinating the delivery. We will need fifteen workers and 5 pick-up trucks with drivers. Members will need to sign up to help and will get 10 free rounds for their time.
 - 2) Winter 5-stand 2022. A motion was made to have 5-stand as a winter shooting activity for 2022. The motion carried.
 - 3) There was discussion about sheds/covers for the 5-stand. There was a motion to buy ten Howell covers for \$900.00. The motion carried.
