1) Call meeting to order: 5:32 PM

- 2) Brief review of the minutes from the January 6, 2021 meeting. Minutes carried as read.
- 3) Treasurer's report: Checking: \$14, 642.00

Savings: \$21,309.00

4) CPW introduction of new officer: Matt Yamashita from CPW came by to talk to the BOM about some of the changes on the rifle and pistol range. He also wanted to introduce Darren Chacon, the new Assistant Wildlife Manager. Darren will be the primary point of contact for RFVSA.

Darren has been working in the valley for several years with CPW. His responsibility will be mostly administrative.

Matt also stated that RFVSA has done a "phenomenal job" of cleaning the range. He also stated that the soils assessment report came back "clear". Matt stated that Colorado Department of Health and Environment feels that there has been no violation and stated that "there is more in place between the club and CPW to mitigate some of these things, more than almost any other range out there."

Security cameras are in place and operational and have been used to quash false accusation of shooting after hours. The cameras are working twenty four hours a day, 7 days a week.

- 5) Committee Reports:
  - a) Safety Report: No Safety report.
  - b) Maintenance Report: Howell traps came up and completed the overhaul on the high house target machine. The machine is working great. Howell Traps will return on Wednesday, March 31st to put in the new wobble machine in the lower trap house. Cory Howell will be listing our old trap machine (upper trap house) for sale. He thinks we can get \$900-\$1,200. Bill told Cory that sale must include that the buyer has to come and get the machine, the club will not pay freight for transfer. Simon from MEC will be coming to deliver the two new machines for the 5stand. Those will be placed on the range in the spring. The warehouse ladder was ordered for the new machine to be placed on top of the low skeet house. Bill purchased two new solar panels. A motion was made to purchase twelve buckets and 8 foot piece of PVC pipe for the shooting ranges for cartridge disposal. The motion carried. There was some discussion of shooting 5-stand in the winter starting 2022. There has been members who want 5-stand in the winter, but the problem has been housing the machines to protect them from the elements. Bill will make a presentation at the next meeting for hard structures for the machines.
  - c) Overhead Platform Report: No report.
  - d) Video Report: Dean Wagner has talked to a gentlemen about doing a safety video. Currently, we have permission to use a safety video produced by the Clark County shooting range in Nevada. Dean spoke with Billy Carr about using that video and some videos that the NRA has produced. This would keep the cost of a video down. Billy feels we could put the safety video on our website and a novice or new shooter could watch the video on their cell phone. Bart mentioned that he had video equipment and he felt that this could be done in house. Dean will have more on the video production at the next meeting.
